

This is with reference to your letter No. WCMSR/Ext./2016/19 dated 21.05.2016 on the above subject.

2. Permission is hereby accorded for attachment of the following Community Health Centre and Primary Health Centres for the purpose of teaching and training of MBBS students in Community Medicine Department in the World College of Medical Sciences & Research, Gurawar, Jhajjar, Haryana subject to the following conditions:-

1. The trainees will not get any residential accommodation.
2. No financial aid to the Managing Trust/ World College of Medical Sciences & Research, Gurawar, Jhajjar will be given for this purpose.
3. Time table will be made by the Civil Surgeon, Jhajjar and will be strictly adhered to by the students of World College of Medical Sciences & Research, Gurawar, Jhajjar.
4. The College authorities will not interfere in the administration of the Hospital.
5. If any additional material has to be purchased for the use of trainees, the expenditure will be borne by the Institute.
6. The Institute/College will have to deposit Rs. three Lakh as refundable security with the Civil Surgeon, Jhajjar towards any damage or loss caused to the machinery and equipment of the hospital by the trainees or trainers of the College. Damage if any shall be recovered/adjusted against this refundable security. This amount shall have to be deposited before the commencement of the training in the above mentioned PHCs and CHC.

7. An amount of Rs. 5000/- per student per annum out of the fees already received from them shall be deposited in Hospital/ Government Treasury through Civil Surgeon, Jhajjar. No extra fee shall be charged from the MBBS Students on this account by the World College of Medical Sciences & Research, Gurawar, Jhajjar, Haryana.
